# **Council Reports**

## **President's Report** James Ramirez Dip Cll

I am delighted to report that the Insurance Institute of Leeds has had another highly successful year and delivered on what we set out to achieve for our members.



Looking back over the last 12 months fills me with a sense of pride in what we have achieved as a team and my heartfelt thanks goes to each and every council member who has contributed to our cause.

Our CPD programme continues to be exceptional, under the leadership of Melanie Jordan the education team have put on a large and varied programme of first-class events. These events have proved highly popular and received very positive feedback.

We have successfully reduced our reserves, and this is largely due to increased expenditure on educational activity. This includes the implementation of the 'Next Generation Leadership' series developed by my predecessor David Ross and the launch of our very first 'Fast Track Diploma Programme'. My thanks goes to our new Treasurer Kim Spence who has a done a great job in managing our finances.

The Emerging Insurance Professionals (EIP) group has been launched – a dedicated committee to meet the needs of young, emerging professionals in the area. The aim is to engage with our young members and encourage their learning and professional development through greater interaction with each other, the Institute and the CII. The success of the group's events to date show that there's a huge appetite for this amongst our membership. I would like to thank all of the committee members who have formed the EIP and served with great passion and energy. I reserve special praise for outgoing chair Gemma Sword Williams, incoming chair Jonathan Catley as well as education team leader Nick Watson and social team leader Holly Copsey. I hope that the group continues to thrive with the support of council.

The Institute is also well positioned to promote insurance and financial services to the next generation of talent who we hope will enter the profession in the future. We have looked to build relationships with local schools and universities, offering our services to deliver Discover Risk/Fortunes sessions, to attend careers fairs and help with mock interviews. A big thank you to incoming President Chris Lockwood who recently spearheaded the delivery of Discover Risk to 180 students at Abbey Grange School. I'd also like to thank Chris for his support as Deputy President and wish him all the best for his term.

In an attempt to connect with our members in different ways and to provide them with timely updates on our events we have tried to be more visible on LinkedIn. I feel as though LinkedIn is a very valuable way of engaging with our members and recommend that we endeavour to pursue and develop our LinkedIn activity. We have also produced two excellent editions of CoverNotes, my thanks to Clive Batchelor and the marketing team for a job well done.

2018 saw our Annual Dinner move to the Royal Armouries. This was something I was very passionate about as I felt it would give us an opportunity freshen up the event and give our members a new experience at what is our flagship event of the year. With thanks to all that supported the change and helped out with the event, especially Dinner Secretary Bernard Thornton and Karen Fothergill. Bernard and Karen worked extremely hard to deliver a great night had by all.

I would also like to thank everyone who has contributed to our fundraising and awareness raising efforts this past year in support of Leeds Mind and the Insurance Charities. The Annual Charity Raffle and fundraising at the Annual Dinner continue to ensure a stable flow of income for us to donate to the charities we support. Thank you to Michelle Gilmore who continues to coordinate these activities with great skill. In addition to our usual activities we added the Yorkshire 3 Peaks challenge to the calendar, this was a fantastic day where we took on a challenge, spent time getting know our members and raised some money for charity at the same time. This event was a real highlight for me.

The Harrogate Local Committee (HLC) continues to be an important part of the institute and with their lectures, social activity and their own annual dinner, the HLC is the envy of other established local institutes. I would like to thank all of the members of the HLC and congratulate Simon Coletta on a successful 2-year term as chairperson.

I have really enjoyed my time as President, I would like to thank David Ross for nominating me and I'd like to thank Karen and the whole of council for their help, guidance and support over the last year. I feel very privileged to have taken on the role, I have found it challenging but also very rewarding. I've had the pleasure of meeting a number of great people along the way and will take away many great memories with me.

## **Treasurer's Report**

#### Kim Spence

I took over the role of treasurer from Clive Batchelor in 2018 the year after the CII started actively encouraging institutes to reduce their accumulated funds from previously unnecessarily high levels. As a result of this there has been an increase in expenditure from  $\pounds$ 72,789.26 in 2017 to  $\pounds$ 117,005.03 in 2018 which is a difference of  $\pounds$ 44,215.77.

In July 2018 we only received a grant of £10,846 as our bank balance was still too high but in January 2019 we received a grant of £29,595 due to lowering our balance and as a result we can expect to receive the same amount in July 2019. This will give us income from grants for 2019 of £59,190 compared to £37,084 in 2018. We received total income of £71,617.67 in 2018 compared to £66,927.80 in 2017 an increase of £3,489.87. Assuming we receive the same levels of income aside from grants then total income for 2019 could be in the region of £92,523.

I am pleased to report that the biggest rise in expenditure was on CPD and Educational Activities from £23,751.12 in 2017 to £59,751.09 in 2018 which has directly impacted our members of the Institute in a positive way. Our main goal is still to focus on providing high quality CPD events for our members.

Our popular annual dinner which we moved to the Royal Armouries for the first time brought in income of £23,260 and outgoings were £21,873.62 therefore it pays for itself.

We will continue to put on social events for our members and although there was a reduction to spending in 2018 compared to 2017 this was mainly due to the fact we supported a 'Style in the City Charity' event in 2017 which we didn't repeat in 2018.

We will of course continue to support our charities going forward and try to put on more events like we did with the 3 Peaks this year which not only raises money for charity but brings people together in the outdoors in a social environment.

Insurance costs were £872.88 in 2018 however, this is not an increase from 2017 as the invoice wasn't given to us in time so it was carried forward into 2018.

Our president's expenses were higher in 2018 but some of this is due to an overlap from 2017 as our presidential year is not the same as our financial year. They are also higher due to the greater number of CPD and Social events our president attended this year which naturally results in an increase in costs.

Other Professional Fees are higher this year as we paid more on member communications such as Covernotes which is sent directly to each members residence.

We are still confident that the Institute remains in a financially healthy condition and we are keen to continue supporting our members as much as possible by putting on events that are of interest to all areas of the Institute.

Particular emphasis is placed on the Council's finances to be sure that our funds are dispersed efficiently for the benefit of our members.

The team is always made up of senior council officers together with the addition of long serving council members. For 2018/19 the team was Peter Moran (Leader), Nick Brabham (Secretary), Chris Lockwood (President Elect), James Ramirez (President) and Kim Spence (Treasurer).

The Team allows all other Council teams to conduct their affairs independently and will only become involved if asked to do so or if there is evidence of a problem.

In addition to two formal meetings, 30 July and 17 December there was regular communication among the Team by telephone and email.

The feedback for this session was very positive and we are already in the process of making contact with other schools.

### **Dinner Secretary Report** Bernard Thornton FCII, Dinner Secretary

The Dinner took place on 2 November 2018 at the new venue of The Royal Armouries. This was no reflection on the services provided by our previous long-standing venue, The Queens Hotel; rather that a new approach was felt to be desirable and some new ideas brought into play.

In the opinion of the organising team and judging by feedback received, the switch was a great success. So much so that the date for the 2019 Dinner (Friday 1 November) has been agreed and a provisional contract signed with the Armouries.

**Budgeting.** A financial report is attached. This is yet to be audited by the Treasurer, but we are confident that a small profit will have been made, which ticks the right box for the annual assessment.

There was a total of 403 attendees of whom 346 paid full price. The balance included serving Council members who were invited free of charge in recognition of their service to the Institute.

For 2019 a modest increase in ticket price from £60 to £65 was agreed at the January Council meeting.

**Transport.** One of the potential problems of moving to the Armouries was the out of town location. In the event this posed very few problems. Only a small number of attendees commented and those who did felt that the benefits of the new venue outweighed any transport difficulties. To minimise any concerns, we laid on a shuttle bus from the city centre but as only 11 people used the service it will not be repeated for 2019.

Liaison with Royal Armouries. Our contact Jessica McGregor could scarcely have been more helpful and was well supported, especially by our duty manager on the night, Sharon Burrows. Overall organisation was excellent throughout.

As always there were a number of smaller details we would alter for the future and a debrief meeting, attended by the President Elect, took place at the Armouries on 25 January.

**Sponsorship.** Ideas for future sponsorship offers have been discussed within Management and will be rolled out shortly. The likelihood is that we will have 3 packages available, which should result in a significantly increased income, enabling a speaker of the highest quality and, in turn, a higher profile and attendance. We thank our long-standing sponsors Independent Appointments who will of course, be given first refusal on future options.

I would like to add my personal thanks to Michelle Gilmore for organising the Charities side and various other Council Members who helped both beforehand and at short notice on the night. Finally special thanks to James and Karen, both of whom did every bit as much work as I did as Dinner Secretary. We all worked extremely well as a team, and it is no coincidence that that the result was a very enjoyable and successful Dinner all round.

The EIP committee was set up mid 2018 bringing together a group of 12 highly engaged and committed emerging insurance professionals, offering a wide range of experience and skill sets. The teams primary aim is to support local members under the age of 35 by providing tailored CPD, networking and social events. The EIP committee report into the main Council and collaborate across all aspects of the Insurance Institute of Leed's activities.

Prior to the launch of the EIP group and following numerous meetings, we agreed on the Emerging Insurance Professionals name. In addition, we also have our own individual page within the IIL website and created a brochure to inform members what we are about. Our work on the LinkedIn page and other social media is ongoing and will continue to advance as the group develops.

All of the EIP events have been very well attended, surpassing all of our initial expectations and hopes when planning earlier in 2018. Across the EIP committee we are excited to build on the success seen during our first few months as a group. We are confident that we can build on this, to further enhance the EIP Group offering to members in Leeds. As a group one of our key objectives is to create an Emerging Professionals Ball however recognise that we need to build our membership further before this is possible.

Our thanks to the main IIL council and in particular James Ramirez (2018/19 President) for the support in coordinating the setup of the EIP Group and the opportunity to speak during the dinner. We look forward to working with Chris Lockwood (President-Elect) and the Council going forwards.
