Fiona Coulter - President

Fiona started her early career with Post Office Counters Ltd as a trainee, she moved to a Regional Business Development trainer role in 1993, where she supported and developed existing and newly appointed Sub Postmasters to grow sustainable and profitable businesses.

In 2001, she moved into the insurance sector, joining IAS, now Ageas UK, as the Training Manager for Northern Ireland. Fiona is a strong advocate for education and professionalism, and as such, introduced the first Financial Services Apprenticeship for existing employees in Northern Ireland.

Fiona then moved to Hughes Insurance in 2009, as the Head of Learning and Development. She embedded CII qualifications as an integral of the new employee onboarding framework and management programmes. The company were awarded a number of industry accolades for their people development initiatives designed by Fiona and her team.

Fiona left Hughes Insurance in 2015 to set up Green Lantern Consultancy, where she works as a consultant, facilitator, coach and mentor to executives, boards and teams within financial services, private and public sector organisations, locally and internationally. Also in 2015, Fiona joined the IINI council as education secretary, later taking up the role of secretary.

In 2020, Fiona was awarded the prestigious IINI Albert Gillespie Memorial Award for contributions made to the insurance profession.

<u>Tim Graham - Deputy President</u>

Tim started his insurance career as a fresh faced 18-year-old straight from school in August 1997 joining Royal & Sun Alliance as a member of the Commercial Underwriting Services team the same day as IINI Vice President Ashley Murphy.

Exam Centres

Discussions are ongoing with CII about the possibility of offering a mobile service in the North West area.

Employers Open Forum Discussion

The IINI Employers Open Forum event took place on the morning of the 26th October 2023 at the Clayton Hotel, Belfast. Phil Turner of the CII kindly agreed to attend and delivered a presentation on the CII's FutureMe and Professional Roadmap facilities.

The floor was then opened to discuss the future direction of IINI activities. Whilst the number of attendees was below what had been hoped for. Those that did attend, were engaged, and provided valuable feedback.

Feedback from IINI Employers Event -26/10/2023

Discussions focussed predominantly on Emerging Professionals and how we, as an Institute engage better with this demographic within our local professional community.

A summary of some of the key points discussed and feedback/suggestions received.

Emerging Professionals/Careers

- Ice Breaker/Freshers Event held annually.
- Student/Emerging Professional Focus group feedback/future direction.
- Better communication by taking advantage of modern communication mediums social media platforms (Twitter/Tik Tok/Facebook etc), Podcast content, Linkedin(Emerging Professionals Page/Account).

- Emerging Professional Sub-Committee.
- Reverse Mentoring/Mentorship programs.
- Exam Support Sessions help with preparing coursework/exam prep incl study groups.
- Importance of bringing this group of people together to socialise and network.

Promoting IINI Events

- Agreeance that Ambassadors will play a vital role in encouraging participation and raising awareness in future IINI events & council participation.
- Feedback around accessibility to events. Time/day of event, location etc.
- Consider providing both face to face and virtual CPD content (recording of live CPD events to be viewed at own time).
- NI Specific Local Newsletter share industry insights, research reports & regulatory updates.

A handful of completed feedback forms have been received to date. These will continue to be collated and shared should any further feedback be received.

RBAI Careers Convention

Careers Officer attended the RBAI (Royal Belfast Academical Institution) Careers Convention on behalf of the IINI on the evening of 7th March 2024.

The event was well attended by approx. 300 Year 12 & Year 13 pupils and their parents.

Several positive conversations took place with both pupils and their parents around career pathways and the diversity of roles and opportunities within the insurance industry in Northern Ireland and beyond.

CII FutureMe literature was provided to all pupils who showed an interest in a future career within insurance.

Annual Dinner

Honorary Dinner Secretary - Gary Ennis

Friday 12th January 2024 and the "place to be" was most certainly the Culloden Hotel. The Stuart Suite was filled – maybe a little overfilled at the back – as our President welcomed 427 guests to her Dinner. It was also great to have 9 of our Award Winners in attendance plus 9 of our Past Presidents adding character to the event.

Our President selected a tasty menu and thanks to her endeavours we were entertained by the outstanding talent of Rachel Tucker with her superb delivery of some West End classics and to round off the evening, local comedian Colin Murphy.

Feedback and comments have been overwhelmingly very positive with compliments coming in for the speeches, the food and the entertainment. Really encouraging to receive very positive feedback from the CII President, the "Chain Gang" and our business guests including the President of the NI Law Society that our dinner continues to be "one of the best".

The vibe continued late into the night and the Culloden once again proved to be a great "package" and despite perhaps having to limit attendees it would be difficult to change venue.

Sponsorship once again played enabling us to keep the professional look of the dinner particularly in relation to video and audio features. We were supported this year by ABL, Allianz, AMET, Applied Systems, AXA, DWF, Prestige and Tughans.

The charity collection raised £8,140 and has been split between the Insurance Charities and our President's nominated Charities for her dinner, Lighthouse NI and K9 Search and Rescue NI.

Despite sponsorship and an increase in the ticket price by £10 the dinner account has finished with a deficit of £14,240.40. In relation to this deficit, I would confirm in summary:

- Total of 427 attendees at the dinner but excluding IINI guests and sponsors there were 272 tickets actually sold.
- We increased the number of IINI guests from 41 to 52 and Council should therefore be contributing £5,720 to the "Dinner account" for these guests.
- We identified during the planning phase a significant "above inflation" increases on all costs particularly the food. We did request an increase in ticket price but this was "held back" by the Dinner Committee to an additional £10 per ticket with an undertaking this year to "underwrite" the deficit. I do think a more realistic approach to ticket price is required for next year to both maintain the high standard of our dinner but to avoid eroding the IINI account surplus.
- Sponsors net contribution to the dinner cost also diminished again due to increased meal cost and drinks. For this year each sponsor contributed £1,670 to dinner expenses. I do not see a lot of room to increase sponsor cost.
- We also had increased costs also for entertainment and drinks.

A final thanks to Fiona for her immense input and putting her personal "stamp" on the dinner particularly with the entertainment and to Mikala for all her "behind the scenes" work over basically a 3 month period and without whom we would be lost.

PFS

PFS Chair - Debbie Connolly

In 2023, the PFS NI Region was able to host all scheduled events and a Chartered Breakfast event before each conference. Numbers were slightly down on previous years with average attendance being between 70 - 100 people.

- Q1 Thursday 27th April in Templepatrick (Chartered breakfast event before main event)
- Q2 Tuesday 13th June Templepatrick (Chartered breakfast event before main event)
- Q3 Tuesday 14th November Templepatrick (Chartered breakfast event before main event)

There are, however, substantial changes to the way that the events will run in 2024. During 2023, I have had several meetings with Don McIntyre and Mark Hutchinson from the PFS to see how we can drive the PFS going forward and to try and modernise and engage new and existing members. We want to ensure that our members are benefiting from their membership. These calls were attended by all regional chairs in the UK and a monthly chair meeting was also organised so that we could all share our thoughts and ideas as well as best practice.

There will essentially be 4-5 quarterly "super events" i.e. similar to the quarterly conferences there are now, but instead of them being in each of the regions, they will only be in 4-5 locations with each region given more freedom to get local speakers of speakers who they believe will add more value for their local members. Help and admin to arrange venues and speakers as well as budget will come centrally from the PFS. My main concern was that Northern Ireland would miss out on the "super events" but give the size and location of our region, we will be one of the regions that can host this.

Further clarification was given at the Officers Conference in Wales in November 2023 and the PFS Convention "Duty Bound". This was useful, and it was great to understand the direction of travel as to what the PFS events will look like going forward. There will be a "super conference" held in Northern Ireland on the 5th June 2024 at the Kingfisher Hotel in Templepatrick, as well as several stand-alone events that will be organised with the committee and the PFS to allow more freedom over the content and the nature of the events to ensure that our members get the best value for their money and time.

The onus is now on the regional committees to arrange and organise their own events and this will happen across the UK. As s a committee, we will need to decide what the future events will look like who the speakers will be, where the events will take place and we have a budget of £10,000 for the year. Further funds may be available from the IINI if required and we can apply for this should we need to

The committee held a meeting on the 14th of December 2023 where we discussed options for future events that could take place in 2024. We are trying to listen to our members as much as possible to try and understand what they want and to try and add as much value as possible. We are also looking at trying to arrange smaller regional events in Northern Ireland, potentially looking at Londonderry/Derry and potentially Armagh/Newry as well. We have also had interest from three younger members of the PFS on joining the committee.

Following our meetings, we are pleased to report that the following events have now been secured, with a few more to follow hopefully, later in the year:

Q1 - Protection & Lifetime Allowance - Tuesday 23rd April at the Clayton Hotel, Ormeau Avenue, Belfast. Registration is now open.

Q2 - XChange Conference – Real World Opportunities - Wednesday 5th June at Kingfisher Templepatrick Hotel

It will take time to arrange events for 2024, as this had been centrally organised before and there was not much of a lead in time from the announcement. However, as a committee we will work tirelessly to ensure that our members get sufficient CPD this year.

Social Media

There is a PFS NI Chartered member LinkedIn site, this is continuing to grow in numbers and has been useful to broaden and develop contacts. Thanks to Paul Kerr, who will take over the running of this and has been granted access rights. Paul will update local Chartered Members with any upcoming events.

The PFS Events app is now also the main way to book conferences going forward and it also then retains the agendas for the events and your CPD certificates etc. Most members are finding this useful, however we do have some advisers that do prefer not to use this.

We have also had more interaction at the events with Slido being implemented so that the feedback for each speaker is given at the time via a QR code. Again, this has been mostly positive, but there are some members who prefer the paper feedback forms and where possible, this has been facilitated.

Professional Qualifications - 2023

The number of people sitting exams for Diploma and Advanced levels has reduced over the last year. There are a number of local institutes who allow access to their courses across the UK for a small fee. These are online courses, and they are shared by the PFS to all members who have opted into receiving emails. To run face to face courses, it would cost more but if the demand is there, we would be happy to investigate running these again.

There have still been some issues in 2023 with PSI when sitting exams but these issues are becoming less frequent. One area of feedback that we have been trying to get help with is having an exam centre located in the North West of Northern Ireland and discussions around this are ongoing with both the PFS and the CII in Northern Ireland.

Financial Education promotion Via Schools

During 2023 Richard has been able to deliver some events at local schools. There have also been several volunteers delivering seminars, in Belfast, Derry/Coleraine etc. I also spoke to Vilma at the PFS about our Education Ambassador to make sure that Richard was aware of any other volunteers attending events at schools around NI as there has been times where efforts have been duplicated. Vilma has agreed to make sure that Richard Girvan is copied in any emails so that this can be monitored more closely, and a more strategic approach can be taken with this.

PFS, CII and IINI Working together

During the year, Brian Caruth and I also met with Martin Rouse who is the Business Development & Marketing Director for the CII/PFS to see how he could help us going forward and continue our good working relationship that the PFS and the IINI have had in Northern Ireland for a number of years.

I also met with Philip Turner and Matt Simmons from the CII who are keen to work with both the CII and the PFS in Northern Ireland to help the local institute develop more connections and try and get more business involved with us. They were very keen to help in any way they can and have agreed to

come across and meet with the PFS committee to explain their role and to show how they can add value for our members.

There has been some turmoil in the press over the last year with the CII and the PFS. However, as a committee in Northern Ireland, we have always worked very well with our local CII colleagues and agreed that fundamentally, we are unlikely to be able to change the outcome of the issues raised and that we want to continue to put on a united front and work together to get the best value and outcome for our members and we did not want politics to get in the way of that.

A few examples of this would be the joint Well-Being event in 2023, where both CII and PFS members could attend no matter what level they are at as this is a particularly important issue that we are all passionate about. Debbie also attends the IINI Council meetings each month along with Geoff Clarke, Brian Caruth and Russell Anderson.

The IINI GALA Dinner

The dinner took place at the Culloden Hotel and was attended by Debbie Connolly in her capacity as Chair of the PFS. It was a great event and lovely to be invited to meet many colleagues and friends. Geoff Clarke was also able to attend the dinner.

IINI/PFS Annual Awards 2023

The annual awards ceremony took place at Queens University on 15th May 2023. It was a lovely day out to celebrate all the great achievements for the Financial Services and the General Insurance exams. It takes a lot of hard work and dedication to complete the exams and I congratulate each and everyone who was able to work towards their goals.

Events

Other than the above, there have been quizzes and a ten-pin bowling event organised by the IINI as well as the always sold out annual Charity lunch which is always expertly organized by Brian Caruth. This was a great day out and it was nice to see some of the committee members in attendance and we want to try and grow this each year. There was also the annual Pantomime which is always a yearly highlight and was again well attended and finally the Christmas Treasure hunt again in December.

The final mention for the report is to thank each committee member for their valued support throughout the year as well as the support given by Alison Tilzey, who always goes above and beyond.
