Education

We had a total of 135 affiliated local institute members sitting examinations in our area with 87 achieving a pass. Within that figure we held two sessions of written examinations, in April and October both sessions being held over three days. The sessions were held at the Holiday Inn Marina, and unfortunately due to other events on at the same time as the exams we had problems with noise. Despite requests by the invigilators we felt that candidates had been affected, so a request was made to London and as a result this was taken into account in the marking for that particular session.

For the 2016/2017 exam year we are moving the examination centre to the Masonic Lodge, Beverley Road, Hull HU3, in an attempt to provide a guieter environment.

I would like to thank all of the invigilators for giving up their time in helping us to continue to hold the examinations in Hull, without these volunteers our members would be left with having to travel to Leeds or York.

To assist members with their studies a revision course for the AF3 paper was arranged, the course was heavily subsidised by the Hull Institute and we were also able to reduce costs due to the generous help afforded by Jelf who provided the use of their premises for the session and also provided food and refreshments for the participants. The cost of the course run by CII approved trainers was £50 to members and was fully subscribed.

We would like to offer further revision courses so would appreciate feedback from members who are taking exams as to what examinations they are due to take so that we could arrange suitable courses.
