

SUMMARY

A flexible, unit-by-unit remote training initiative for learners wanting support to help them achieve their Certificate in Insurance (Cert CII) qualification.

- Learners can get support for all three units needed for Cert CII over nine months, beginning with IF1 Insurance legal and regulatory followed by a choice of future units.
- Equally, learners can get support for the individual units they are studying outside a fixed programme.

CERT CII TRAINING STRUCTURE

Remote training on Cert CII units is based on a set of sessions going through the detail of the textbook, supported by end of chapter questions. This is followed by revision sessions based on mock exams and revision quizzes
